TERMS OF SALE

Our terms are net 30 days from invoice date with approved credit.

FREIGHT

All sales are F.O.B. Factory. Items are shipped by a fast/standard method unless otherwise specified, with shipping charges and insurance prepaid and added as a separate charge on your invoice. Click on the "Shipping" link for additional shipping options.

CREDIT

Shipments on open accounts will be made only to entities that have established credit. If credit has not been established with Complete Curb Products, terms may be payment in advance or C.O.D.

QUOTATION AND ORDER

Quotation of pricing for goods and services are warranted for 90 days. They are only negotiations to trade and are not contractually binding. Orders are effective when accepted and acknowledged by the office of Complete Curb Products, Houston, Texas.

STORAGE

Complete Curb Products does not provide storage facilities. All charges and expenses incurred as a result of delay in manufacturing or delivery of goods due to causes within the buyers control, are the responsibility of the buyer.

DAMAGE RESPONSIBILITY AND CLAIMS

Responsibility for loss or damage to goods in transit or for delays of carrier in delivering goods, is not the responsibility Complete Curb Products. Once goods are consigned to the carrier by CCP, they become the responsibility of the buyer. All claims must be reported to the carrier immediately, failure to do so makes you, the customer, liable for payments of those goods should untimely claims be rejected by the carrier. All claims must be made within 7 days of receipts of goods. CCP will provide any documentation in it's possession to assist you in resolving your claim with the carrier.

RETURNED GOODS AND BACK CHARGES

No returns will be affected for credit without prior authorization, and are subject to approval by Complete Curb Products. If, for any reason, it is necessary to return goods to us, please contact your sales representatives for the appropriate return instructions. Non standard size products are not returnable. CCP will not accept back charges for repairs or changes to products shipped without prior approval.
